Kevin D. Reed is the President of The Green Cross, a medical cannabis collective that has operated since July 2004, first as a Medical Cannabis Dispensary (MCD) and later as a delivery service.

Kevin moved to San Francisco from Alabama in 1996, right after voters passed Prop. 215. In 2003, a disillusioning encounter with the SFPD planted the seeds for Kevin's emergence as a strong and tireless advocate for cannabis patients and the operators of medical cannabis collectives.

In 2005 - 2006, Kevin partnered with other MCD owners and patient allies to help advocate for MCD legislation in San Francisco.

Your Health! We make it our Business.

Is your operation legal?

Yes. In 1996 California voters passed Proposition 215, an initiative approving the use of cannabis for medicinal purposes. In 2007 the City of San Francisco passed a comprehensive regulatory structure for medical cannabis dispensaries (MCD), requiring an extensive application process to secure a building permit and licence to operate. On January 7, 2008 The Green Cross was the first MCD to complete the process and receive a building permit and license to operate from the City of San Francisco.

Who are the Patients of the Green Cross?

Patients become Green Cross members by demonstrating proper documentation. There is no membership fee. In compliance with state and local SF laws, The Green Cross requires patients to have a current recommendation from a medical professional, and a California drivers license to obtain a Green Cross membership card.

All of us at The Green Cross are supporters of the Medical Cannabis Movement and seek to protect patients' right to make their own medical decisions.



What cannabis products are available through The Green Cross?

The Green Cross maintains some of the highest quality and most affordable strains of indica, sativa and hybrid strands of cannabis. We also carry a large range of alternative methods of treatment, very tasty edibles, concentrates, sprays, oils, tinctures, teas, pills and more. The Green Cross also carries a small line of stylish apparel.



Our Contributions

Educational Efforts: The Green Cross engages on multi-levels of educational initiatives: We provide patients with a packet of important educational materials that every medical cannabis patients should have. The Green Cross is also one of the founders and leaders of the Compassionate Care Council, a trade association for medical cannabis collectives that has provided guidance to SF City officials as the regulations for dispensaries were drafted and redrafted. We are often invited to speak at college and university health classes or seminars, and do so on a regular basis.

Embracing multiple objectives, The Green Cross created an on-line community forum to: educate the general public, create a space where our community can inquire, discuss issues, explore priorities, and when needed organize itself!

Community Support: The Green Cross is aware of what its neighborhoods needs are. We donate part of our proceeds to local community centers and maintain a continuous effort to keep our adjacent streets clean and safe for neighbors and ourselves.

Our Patients Health is our Priority:

We have created a line of smokeless cannabis products. From edibles to drinking teas to oils, we are conscious that smoking is not the safest form of consumption. We are constantly researching alternatives and improvements on our already vast menu options.

Community Outreach: By developing tools like our monthly newsletter, our online community forum and our easy to understand educational materials, we look to be a resource for all medical cannabis patients in San Francisco and beyond.

Senior Citizen Discount Program: 10% off all medication. Available all day on the 2nd Sunday of every month for seniors 65 and over.
